## **BRITISH COLUMBIA VICTIMS OF CRIME ACT**

THE BRITISH COLUMBIA VICTIMS OF CRIME ACT (VOCA) PROVIDES CERTAIN RIGHTS TO VICTIMS OF CRIME, INCLUDING:

- the right to be treated with courtesy and respect and without discrimination by all justice system personnel
- the right to receive information on the justice system, victim services, and related legislation
- the right to receive certain case-specific information on the investigation, prosecution, sentencing and release of the offender
- the right to be given a reasonable opportunity to provide victim impact information for presentation to the court before sentencing
- the right to receive independent legal representation, if there's an application for disclosure of personal information

### LIMITS ON CONFIDENTIALITY

VICTIM SERVICES CASEWORKERS TREAT ALL FILES AS CONFIDENTIAL, WITH THE FOLLOWING LIMITATIONS

- ✓ We must report to police any information you disclose about matters of criminal nature.
- ✓ We must report any evidence of child abuse or neglect to the Ministry of Child and Family Development.
- We and/or our files may be subpoened in any court proceeding related to your case. If Victim Services files are subpoened, you have the right to counsel through Legal Aid in order to protect your interests. You do not have to meet financial eligibility requirements to obtain Legal Aid in this circumstance.
- Victim Services caseworkers may exchange information directly relating to your file with any authorized person or agency when making a referral to that person or agency on your behalf and with your consent.
- Finally we are obligated to inform police if your condition or situation indicates that you or others are in a dangerous or potentially dangerous situation.
